MOORING TRANSIENT USE PROGRAM

The following plan was designed to allow persons on the waiting list to use moorings on a short term basis when they are unoccupied by the mooring holder. Any person wishing to use a mooring or float must follow the rules listed below and **MUST HAVE PERMISSION FROM THE HARBORMASTER PRIOR** to using a mooring or float.

1. All mooring holders must still comply with the Pamet Harbor rules and regulations including the thirty day annual rule, unless waived by the harbormaster.
 2. All mooring holders will provide the harbormaster with the dates the mooring is expected to be used.
 3. Persons on the waiting list will notify the harbormaster of dates wishing to use a mooring.
 4. The harbormaster will place people on a mooring or float based on the order of the wait list.
 5. Persons on the waiting list must have a seasonal launch sticker to use a mooring or float on a transient basis, or be a current mooring holder wishing to upgrade to a better location. (Float use also requires permission from both persons assigned to that float **prior** to use)
 6. The rules regarding subleasing of floats or moorings will be strictly enforced. Any violations of any of the rules may be considered as grounds for removal from the mooring field and/or wait list.
 7. Use of moorings or floats may be limited to thirty days continuous use.
 8. Transient mooring users must sign the conditions of use form, and must vacate the mooring immediately upon request of the harbormaster and/or the float or mooring holder.
 9. Mooring holders are requested to give at least three days' notice to people who must vacate the mooring or float.
 10. Each **mooring user** is responsible for maintaining a secure mooring, lines, and ground tackle at all times and is responsible for any damage or injury caused by his or her vessel.
